

## CITILINK POLICY REGARDING BUSES EQUIPPED FOR PERSONS WITH DISABILITIES

Citilink buses are accessible to persons with disabilities. It is Citilink policy to provide alternative transportation to persons unable to access a bus because of an inoperative lift or ramp, with an accessible vehicle within 30 minutes. Alternative transportation may be requested by asking the driver of the bus without a properly functioning lift to dispatch a vehicle to your location or by calling the Citilink office directly at (260) 432-4546.
